### **ADMISSION UNDER SELF FINANCING CATEGORY / NRI SPONSORED QUOTA:**

**FOR SELF-FINANCING CATEGORY:** The eligible candidate(s) whose name is shown in the Merit List(s) and are desirous to apply under **Self Financing Category** may apply online by or before **30-09-2021**. The students can apply by clicking on the tab **(Apply For Payment Seat)** in admission portal available on University website and deposit fee of **Rs 500/-** (non-refundable) either online or offline at any branch of J&K Bank Ltd against a print out of the auto-generated pay-in-slip. They need not to submit the hard copies of their Self-Financing Application Form and Fee Receipt to the University at this point of time, however, the original Fee receipt may be required later for admission purposes if the candidate is selected.

**FOR NRI SPONSORED QUOTA:** The eligible candidate(s) desirous to apply under **NRI Sponsored Quota** are advised to submit application in the **Office of the Dean Academic Affairs, IUST Campus Awantipora** on any working day by or before **30-09-2021 (except on Saturday & Sunday)** alongwith application fee of Rs. 500/- and copy (ies) of required NRI Sponsored documents as mentioned in the University Prospectus 2021.
