- The candidates having **Single Asterisk Mark (*)** superscribed on their Form Numbers are already admitted candidates and are advised to report to the office of the Dean Academic Affairs alongwith original TFW documents.
- Selected candidates need to submit an affidavit from 1st Class Magistrate to the effect that he/she has submitted genuine documents/information for availing TFW benefits.
