Expression of Interest (EOI) for Supply, Installation and Commissioning of Two (02) No's of Eight (08) Passenger Lifts at Islamic University of Science & Technology (IUST) campus, Awantipora.

On behalf of the Vice-Chancellor Islamic University of Science and Technology, Awantipora, Pulwama, J&K, Expression of Interest (EOI) is invited from the for supply, Installation and Commissioning of 02 No's of 08 Passenger Lifts in Rumi Library block and Civil & Mechanical block at IUST Campus, Awantipora, Pulwama J&K from reputed registered Lift manufacturers/Suppliers as per terms and conditions of the Tender document available at website (www.islamicuniversity.edu.in).

#### Basic Features of the Lift:

#### The minimum basic features of the lift shall include the following:

- 1. Vandal Proof Stainless Steel Cabin
- 2. SS Handrail on One Side
- 3. Brail Buttons
- 4. Handicap Friendly Access
- 5. Camera Interface with Cable
- 6. Lift floor Announcement System
- 7. 2 Hour fire Rated doors
- 8. Fireman Control Switch
- 9. Automatic Rescue Device
- 10. Emergency Alarm
- 11. Emergency Lights
- 12. Intercom Facility
- 13. Lift Attendant Function
- 14. Automatic Phase Reversal Device
- 15. Central Opening doors with full viewing pane
- 16. Speed of 1 mps
- 17. Ventilation Cross Flow Fan

#### **ELIGIBILITY**

### THE MANUFACTURER/SUPPLIER SHALL HAVE TO FULLFILL ALL THE ELIGIBILITY CRITERIA MENTIONED BELOW

- I. The manufacturer/supplier shall have to provide the information as per Annexure 1 to 2 as attached with this document.
- II. The manufacturer/supplier should submit proof of their registration along with company profile.
- III. The manufacturer/supplier should submit a copy of PAN card, ITR for last five financial years.
- IV. The manufacturer/supplier should submit the Turn Over Certificate attested by Registered Chartered Accountant.
- V. The manufacturer/supplier should submit the list of works executed in last five financial years in any Govt/Autonomous/Semi Govt institution with Completion Certificates and Performance Certificates, if any.
- VI. The manufacturer/supplier should have experience of minimum 5 years in the field of supplying, installation and commissioning of Lifts to a university of repute / hospital / govt. / semi govt. institution.
- VII. All the completed projects should have been executed from the stage of conceptual planning to periodic inspection and completion
- VIII. The manufacturer/supplier should give details of the works undertaken from 1st January 2015 to 31st March 2020, List of Details of past and present clients.
- IX. The manufacturer/supplier should furnish a legal document in the form of an Affidavit guaranteeing the truth and accuracy of all statements and of all answers to questions made.

X. The manufacturer/supplier is required to furnish all information, failing which the proposal is liable to be rejected.

NO EXCUSE AS REGARDS FOR WANT OF INFORMATION ON ANY PARTICULAR POINT WILL BE CONSIDERED AFTER THE PROPOSAL HAS BEEN RECEIVED.

# Phase 1:

The manufacturers/Suppliers will have to give a presentation on 22<sup>nd</sup> of March 2021 at 11:30 a.m. in Conference Room of Admin Block.

- 1. CONFERENCE INTEGRATIVE SESSION (PRE BID MEETING) (22<sup>nd</sup> March 2021).
  - I. There shall be a conference interactive-session at IUST Campus for the applicants on 22<sup>nd</sup> March 2021 at 11:30 hrs.
  - II. The manufacturer/supplier should submit the following during interactive session / pre bid meeting:

A written concept not more than 02 pages highlighting the design/ services to be offered. The manufacturer/supplier will be required to submit his methodology of design and a brief concept on his vision and perspective for the same at the time of Conference Integrative Session (pre bid meeting.)

III. Any doubt of applicants shall be clarified besides discussions on any additional conditions proposed by the applicant as found necessary. An addendum / corrigendum to the tender document would be issued, if required and no further query/condition shall be entertained thereafter.

# Phase 2:

- 1) The shortlisted manufacturers/Suppliers will have to quote their financial bid in sealed envelope addressed to: *Executive Engineer, Islamic University of Science & Technology (IUST)* by or before 25<sup>th</sup> of March 2021 before 15: 00 hrs.
- 2) The bids of the shortlisted manufacturers/Suppliers will be opened on 26<sup>th</sup> of March 2021.
- 3) The manufacturers/Suppliers are requested to visit the site before the presentation to clear any doubts, if any.

## Phase 3:

- 1) The successful bidder shall have to deposit the Earnest Money of Rs. 50,000/- as Security Deposit.
- 2) The DLP shall be calculated from the date of the certificate of completion of work and shall be 18 months.
- 3) Schedule of Payment: Material at site: 50%
- 4) Final payment on completion and commissioning of work
- 5) Maintenance: Free maintenance upto 24 months after completion of DLP.
