Provisionally selected candidates are hereby informed to report to the **Office of the Dean Academic Affairs, IUST Campus Awantipora** on any working day by or before **28-08-2023 (except on Saturday & Sunday)** alongwith application form/ original documents/ copies thereof and requisite fee as mentioned in the prospectus 2023 available on university website for completion of admission formalities. any candidate fails to report within the stipulated time, the seat shall be allotted to the next candidate in order of merit and preference.

3. The candidates having **SINGLE ASTERISK MARK (*)** superscribed on their Form Numbers are already admitted candidates and they have been **automatically** upgraded from one branch to another branch in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded branches for future references.
4. The candidates having **DOUBLE ASTERISK MARK (**)** superscribed on their Form Numbers have been upgraded from reserved category to OM in the already allotted branch/ programme in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded category for future references.
5. The candidates having **TRIPLE ASTERISK MARK (***)** superscribed on their Form Numbers have been upgraded from Self-Finance category to General category in the already allotted branch/ programme in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded category for future references.
6. The candidates having **HASH MARK (#)** superscribed on their Form Numbers are already admitted candidates in General / SF category and have been now selected in SF / General category respectively in another branch as per their merit and preference, such candidates are advised to report in writing to the Office of the Dean Academic Affairs, IUST Campus Awantipora on any working day by or before **28-08-2023 (except on Saturday & Sunday)** for the final allocation of their branches, failing which they shall be considered in the already registered/ admitted branch.
7. The candidates bearing Form Numbers 225720, 225668, 225728 selected in B. Voc. (ML&MDT) were assigned rank of 53, 62, 69 respectively based on their submission of CUET Percentile score. However, after the issuance of Merit list & subsequent selection lists, these candidates have represented that they had erroneously mentioned their percentile score instead of normalized score and have requested to consider their normalized score for admission which has been approved by the competent authority. Accordingly, their rank shall be 8, 23, 33 respectively.
8. The candidates bearing Form Numbers 224556, 224829 selected in MBA (5-Year Integrated) were assigned rank of 124, 256 respectively on the basis of qualifying examination result. However, after the issuance of Merit list & subsequent selection lists, these candidates have represented that they had erroneously not-mentioned their CUET score and have requested to consider their CUET score for admission which has been approved by the Competent Authority. Accordingly, their rank shall be 27, 62 respectively.
9. In case of any available vacancy (ies) after **28-08-2023**, further upgradation of branch shall be done in the subsequent Selection Notifications based on merit & preference amongst the **ALREADY ADMITTED CANDIDATES ONLY**.
