Provisionally selected candidates are advised to upload the requisite documents in the admission login page and are hereby informed to report to the **Office of the Dean Academic Affairs, IUST Campus Awantipora** on any working day by or before **21-07-2026** alongwith all original documents and requisite fee as mentioned in the admission guidelines available on the university website for completion of admission formalities. In case any candidate fails to report within the stipulated time, the seat shall be allotted to the next candidate in order of merit.
3. The candidates whose Form Numbers are superscribed with a **DOUBLE ASTERISK (**)** have been upgraded from a reserved category to OM, in the branch/ programme already allotted to them, based on their merit and preference. Such candidates are not required to visit the University again and are advised to download the updated admission letter from the admission login page.
4. The candidates whose Form Numbers are superscribed with a **TRIPLE ASTERISK (***)** have been upgraded from **SF/SQ to General/SF**, respectively, in the branch/ programme already allotted to them, based on their merit and preference. Such candidates are advised to collect the excess fee deposited, if any, from IUST and note the allotment under the upgraded category for future reference.
5. The candidate whose Form Number is superscribed with a **HASH MARK (#)** is already admitted in the **General** Category in one branch and has now been selected in another branch under **SF** category based on his/ her merit and preference. The candidate is advised to report to the Office of the Dean Academic Affairs, IUST Campus, Awantipora, on any working day by or before **21-07-2026** for final allocation of the branch. Failing this, he/she shall be retained in the branch in which he/she is already registered/ admitted.
