Provisionally selected candidates are advised to upload the requisite documents in the admission login page and are hereby informed to report to the **Office of the Dean Academic Affairs, IUST Campus Awantipora** by or before **22-09-2026** alongwith all original documents and requisite fee as mentioned in the admission guidelines available on the university website for completion of admission formalities. In case any candidate fails to report within the stipulated time, the seat shall be allotted to the next candidate in order of merit.
3. The candidates whose Form Numbers are superscribed with a **SINGLE ASTERISK (*)** are already admitted to AMCN&MT College under OM and have been automatically upgraded to SMMCN&MT College under OM on the basis of their merit and preference. Such candidates are advised to visit the University and collect their updated Upgradation Letter and note the allotment of the upgraded college for future reference.
4. The candidates whose Form Numbers are superscribed with a **DOUBLE ASTERISK (**)** have been upgraded from SF to OM in the college already allotted to them, based on their merit and preference. Such candidates are advised to collect the excess fee, if any, deposited by them from IUST and note their allotment under the upgraded category for future reference.

NOTE: A candidate allotted a seat under **OM or SF** in any college who fails to complete the prescribed admission formalities by **22-09-2026** shall not be considered for any subsequent upgradation, including college upgradation or category upgradation from **SF to OM**, in any subsequent Selection Notification.
