In case any candidate fails to report within the stipulated time, the seat shall be allotted to the next candidate in order of merit.
3. The candidates whose Form Numbers are superscribed with a **DOUBLE ASTERISK (**) have been upgraded from SF to OM in the college already allotted to them, based on their merit and preference. Such candidates are advised to collect the excess fee, if any, deposited by them from IUST and note their allotment under the upgraded category for future reference.**

NOTE: A candidate allotted a seat under **OM or SF** in any college who fails to complete the prescribed **admission formalities by 24-09-2026** shall **not be considered for any subsequent upgradation**, including **college upgradation or category upgradation from SF to OM**, in any subsequent Selection Notification.
