Provisionally selected candidates are hereby informed to report to the Office of the Dean Academic Affairs, IUST Campus Awantipora on any working day by or before 11-09-2023 (except on Saturday & Sunday) alongwith application form/ original documents/ copies thereof and requisite fee as mentioned in Prospectus 2023 available on university website for completion of admission formalities. In case any candidate fails to report within the stipulated time, the seat shall be allotted to the next candidate in order of merit and preference.
- 3. The candidates having **SINGLE ASTERISK MARK (*)** superscribed on their Form Numbers are already admitted candidates and they have been automatically upgraded from one course to another in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded course for future references.
- 4. The candidates having **DOUBLE ASTERISK MARK (**)** superscribed on their Form Numbers have been upgraded from reserved category to OM in the already allotted course in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded category for future references.
- **5.** The candidates in the Waiting List (s) are advised to remain in touch with the university website or with the Office of Dean Academic Affairs IUST for ascertaining chances of their admission in case of any vacancy after **11-09-2023.**
- 6. In case of any available vacancy (ies) after 11-09-2023, further upgradation of course (wherever applicable) shall be done in the subsequent Selection Notifications based on merit & preference amongst the ALREADY ADMITTED CANDIDATES ONLY.
- 7. The candidate bearing Form Number 224535 selected in M. A Political Science was assigned rank of 55 on the basis of qualifying examination result. However, after the issuance of subsequent selection lists, the candidate has represented that she had erroneously not-mentioned her CUET score and has requested to consider her CUET score for admission which has been approved by the Competent Authority. Accordingly, her rank shall be 26.
