In case of any discrepancy found at any point of time, the University reserves the right to cancel/ modify such selection/ admission.
2. Provisionally selected candidates are advised to upload the requisite documents in the admission login page and are hereby informed to report to the **Office of the Dean Academic Affairs, IUST Campus Awantipora** on any working day by or before **25-06-2026 (except on Saturday & Sunday)** alongwith all original documents and requisite fee as mentioned in the admission guidelines available on the university website for completion of admission formalities. In case any candidate fails to report within the

stipulated time, the seat shall be allotted to the next candidate in order of merit and preference.

3. The candidates whose Form Numbers are superscribed with a **SINGLE ASTERISK (*)** are already admitted candidates and have been automatically upgraded to another branch based on their merit and preference. Such candidates are not required to visit the University again and are advised to note the allotment of their upgraded branch for future reference.
4. The candidates whose Form Numbers are superscribed with a **DOUBLE ASTERISK (**)** have been upgraded from a reserved category to **OM**, in the branch already allotted to them, based on their merit and preference. Such candidates are not required to visit the University again and are advised to note the allotment under the upgraded category for future reference.
5. The candidates whose Form Numbers are superscribed with a **TRIPLE ASTERISK (***)** have been upgraded from **SF/SQ to General/SF**, respectively, in the branch already allotted to them, based on their merit and preference. Such candidates are advised to collect the excess fee deposited, if any, from IUST and note the allotment under the upgraded category for future reference.
6. The candidates whose Form Numbers are superscribed with a **HASH MARK (#)** are already admitted in the **General/ SF/ SQ** Category in one branch and have now been selected in another branch in different category based on their merit and preference. Such candidates are advised to report to the **Office of the Dean Academic Affairs, IUST Campus, Awantipora**, on any working day on or before **25-06-2026** (except Saturday and Sunday) for final allocation of their branch. Failing this, they shall be **retained** in the branch in which they are already registered/ admitted.
7. In the event of any vacancy(ies) arising after **25-06-2026**, further upgradation of branches shall be carried out through subsequent Selection Notifications, strictly on the basis of **merit and preference**, among the **already admitted candidates only**.
