#### IV. How to Apply:

The eligible candidate can apply online and deposit fee of Rs. 300/- online and submit the downloaded application form and supported by attested copies of all relevant documents, certificates, and testimonials in the **Concerned Department/Centre of IUST** on any working day by or before the last date (except Saturday/ Sunday/ holiday) for submission of hardcopies, failing which the online application form submitted by the candidates shall not be considered.

#### V. Selection procedure:

The shortlisting of the candidates for interview shall be made as per the criteria / parameters of UGC Regulations-2018 (*Appendix II (Table 3A)* and the criteria for shortlisting of candidates for interview for the post of Assistant Professor shall be as follows: "20 candidates shall be shortlisted for one post and 05 candidates for every additional post", and the final Selection shall be made strictly in terms of the UGC Regulations 2018 (interview only).

The panel recommended by the Selection Committee shall be valid for one year and during this year, if any vacancy arises du to resignation or any other reason, the vacancy shall be filled from the panel.

- 1. The applications shall have to be submitted through the University portal <a href="www.iust.ac.in">www.iust.ac.in</a> under the specified tab.
- 2. Candidates will have to produce original documents relating to their qualification, experience etc. at the time of appearing in the interview.
- 3. No TA/DA shall be paid to candidates for appearing in the interview.
- 4. Eligible candidates will be informed about the date and place of interview through university website / e-mail/ whichever suitable. However, University does not take any responsibility for non-receipt or delayed receipt of the intimation by a candidate.
- 5. Candidates who have been awarded postgraduate/Ph. D degree from Foreign University should enclose Equivalence Certificate" issued by the Association of Indian Universities (AIU), New Delhi without which their candidature will not be considered, and application form will be rejected.
- 6. All relevant information /updates shall be uploaded on university website www.iust.ac.in .The candidates are advised to remain in touch with university website and notifying the same in newspapers shall not be obligatory on university part.

- 11. The engagement shall also be subject to the terms and conditions as may be prescribed in engagement orders.
- 12. The time taken by candidates to acquire PG / M.Phil and /or Ph.D degree shall not be considered as teaching / research experience. The period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave (Part time), shall be counted as teaching experience subject to the submission of certificate to this effect issued by the concerned employer.
- 13. Qualifications / Experiences shall be counted as on the last date of submission of the application forms.
- 14. Any publications in predatory / dubious journals or presentations in predatory / dubious conferences shall not be considered for academic credit for selection & confirmation. With effect from 14-06-2019, research publications from journals indexed in UGC-CARE List only would be considered for all academic purposes.
