Online applications are invited from eligible candidates for engagement as Tutor on contractual basis for the academic arrangement 2025 in the following Nursing College:

I. Emoluments: 35,000/- per month

II. Tenure:

The engagement is initially for the year 2025 ending 31st December, 2025 or till the post is filled on substantive basis (whichever is earlier) and is extendable on the basis of annual performance appraisal by the University based on the recommendations of the concerned Principal of the College, Student feedback, requirement and other related parameters.

III. Leaves/Vacations:

As per norms of the university governing such engagements.

IV. How to Apply:

Eligible candidates shall apply online and pay the requisite fee of **Rs 300/-** (non-refundable) and thereafter submit the hard copy of the application form along with self-attested copies of the documents and certificates in the office of Principal College on any working day by or before the last date for submission. The candidature of those who fail to submit the hardcopies shall not be considered.

V. Screening / Shortlisting / Selection Procedure:

The selection shall be on the basis of interview for which the date(s) shall be notified separately. In case the number of applications is more, "20 candidates shall be shortlisted for one post and 05 candidates for every additional post", Further, the panel recommended by the selection committee shall be valid for one year and during this year, if any vacancy arises due to the resignation or any other reason, the vacancy shall be filled from the panel.

VII. Terms and Conditions:

- a) The applications shall have to be submitted through the University portal www.iust.ac.in under the specified tab.
- b) Candidates will have to produce original documents relating to their qualification, experience etc. at the time of appearing in the interview.
- c) No TA/DA shall be paid to candidates for appearing in the interview.
- d) The time taken by candidates to acquire PG / M.Phil and /or Ph.D degree shall not be considered as teaching /research experience. The period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave (Part time), shall be counted as teaching experience subject to the submission of certificate to this effect issued by the concerned employer.

- e) Qualifications / Experiences shall be counted as on the last date of submission of the application forms.
- f) Any publications in predatory / dubious journals or presentations in predatory / dubious conferences shall not be considered for academic credit for selection & confirmation. With effect from 14-06-2019, research publications from journals indexed in UGC-CARE List only would be considered for all academic purposes.
- g) An undertaking is to be given by the candidate stating that 'the publications submitted by him / her are free from any plagiarism and if any plagiarism is found later, his / her candidature/selection shall stand rejected'.
- h) In case of any disputes /suites or legal proceedings against the University, the jurisdiction shall be confined to the court of Srinagar only.
- i) The engagement of the recommended candidates shall be subject to the outcome of the writ petition(s) (if any) pending in the Hon'ble Courts of J&K.
- j) Eligible candidates will be informed about the date and place of interview through University website/e- mail whichever deemed suitable by the University and shall not take any responsibility for non-receipt or delayed receipt of the intimation by a candidate.
- k) Candidates who have been awarded postgraduate/Ph.D degree from Foreign University should enclose Equivalence Certificate" issued by the Association of Indian Universities (AIU), New Delhi without which their candidature will not be considered, and application form will be rejected.
- I) All relevant information /updates shall be uploaded on University website www.iust.ac.in. The candidates are advised to remain in touch with University website and notifying the same in newspapers shall not be obligatory on University part.
