- I. The applicants bearing above mentioned Applications Form Numbers are supposed to report to the office of the Dean Outreach, Ground Floor, Academic Block-IV, IUST Campus, Awantipora from **18-08-2026 to 24-08-2026** on any working day between **09:00 am – 4:30 pm** along with the original documents for completion of selection formalities, failing which their engagement shall be cancelled and the next candidate(s) in order of merit will be selected.
- II. The engagement of the applicant (s) is strictly provisional and subject to the fulfilment of eligibility criteria as determined and fixed by the university and also on production of Qualifying Examination Certificate, Degree Certificate, Aadhaar Card, Bank Passbook with 16-digit code including IFSC Code and Branch Name. In case of any discrepancy found at any point of time, the University reserves the right to cancel the engagement without assigning any reason thereof.
- III. The University shall verify the antecedents or documents submitted by a candidate at any time of the engagement. In case, it is detected at any point of time, that the documents submitted by the candidate are fake or the candidate has undesirable/ clandestine antecedents and has suppressed any information, then his/her engagement shall be terminated *ab-initio* and university may take any other disciplinary action against such candidates.
- IV. The engagement is purely temporary and for a period of **One year only** without any further extensions, subject to the satisfactory performance and behaviour during the Apprenticeship period and does not in any form constitute any form of employment in the University.
- V. The engagement of the Apprentices shall be governed by the rules and regulations as prescribed by the university (IUST) and NATS with amendments from time to time.
- VI. In case the Apprentice intends to discontinue/ resign, then he/she shall have to give one month advance notice in writing or forfeit one month's stipend in lieu thereof.
- VII. In case of any available vacancy (s), further allocation of Apprentice shall be done on the basis of requirement, merit and feasibility.
- VIII. No university Transport/Hostel facility shall be provided to the Apprentices during the Apprenticeship Training Programme at IUST.
