COURSE DESCRIPTION

This course introduces students to the key forces that have shaped the modern world through the lenses of geography, history, and politics. It explores spatial dynamics and the role of geography in shaping power relations; traces global historical shifts from empire to colonialism and the modern state; examines core political concepts and ideologies; and analyses major contemporary transformations, including wars, globalization, and emerging global challenges.

Emphasizing both historical depth and global breadth, the course equips students with analytical tools to understand spatial dynamics, historical developments, and the political ideas that continue to influence contemporary societies.

- Analyze the relationship between geography, power, and political structures.
- Examine major historical transitions, including empire, colonialism, and the formation of the modern state.
