### **For the disposal/auction of the old condemned obsolete office equipments and furniture item – reg.**

Sealed tenders are invited for disposal / auction of old condemned, obsolete office equipments and furniture etc. on “as is where is” basis (list of items enclosed).

The items to be auctioned are located in the stores, Islamic University of Science and Technology, Awantipora, Pulwama, J&K. Details for inspection, contact person, tender acceptance are as under:-

Date & Time and place for acceptance of tender	In the tender box kept in the office of the Procurement and Stores, IUST, Awantipora, Pulwama, J&K during the office hours upto 12.00 noon on or before 16-06-2022
Date & Time for opening of tender/Allotment shall be made on the same date	16-06-2022 at 2.00 PM. An EMD for Rs. 20,000/- (Rupees Twenty Thousand only) should be deposited with the tender in the form of an CDR/FDR from any scheduled bank in favour of “Finance Officer, IUST, Awantipora, Pulwama”, payable at Awantipora

### **General Terms & Conditions:**

1. Bidders may inspect the items on the stipulated date & time.
2. The items shall be sold to the highest bidder. The bids are invited for the lot (i.e. all the items contained in the list of old condemned, obsolete office equipment and furniture items as a whole and no bid shall be accepted for any part of the same.
3. The handling/disposal of IT related equipments such as printers, fax machines, photocopiers, etc. as per the last guidelines/instructions of Ministry of Environment & Forests and its related agencies shall be the sole responsibility of the bidder(s).
4. The successful bidder has to make full payment, in the form of Demand Draft in favour of Finance Officer, IUST payable at Awantipora within three days after confirmation, failing which the offer will be cancelled and the EMD shall stand forfeited. The EMD of bidders shall be returned within 15 days after the auction date, without any interest.
5. No item once disposed to the successful bidder shall be taken back by the University on any condition whatsoever.
6. The successful bidder will be required to lift all the items from the disposal site within three days after the payment. On failure to do the University shall have the right to forfeit the entire amount of the

- bidder and dispose the items to alternate bidder. The successful bidder will also be required to make their own arrangement of transport, labour etc. for lifting the disposed items.
7. Quotation letter in sealed envelope marked "Tender for Disposal/Auction of old condemned, obsolete office equipment and furniture items" should be addressed to Assistant Registrar, Procurement & Stores, Islamic University of Science and Technology, Awantipora, Pulwama, J&K.
  8. The quotation must be dropped in the tender box mounted in the office of the Procurement & Stores on or before the due date and time. Tenders received after the due date and time shall not be accepted.
  9. The financial bid should be given in both figures and words. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the tenderer.
  10. University reserves the right to accept or reject any of the quotations without assigning any reasons whatsoever.
  11. Each page of tender document should be signed by the bidder(s)
  12. Incomplete and unsigned quotation is liable to be rejected.
  13. Bidder must enclose copy of I.D./Address proof (Aadhar Card/Driving License, Pan Card) along with his / her bid.
  14. The earnest money deposit (EMD) of Rs. 20,000/- (Rupees Twenty Thousand only) must accompany the quotation, without which the bid shall be summarily rejected.
