#### <u>Objective</u>

The Islamic University of Science & Technology, Kashmir intends to coach / train its outgoing students and other potential / interested candidates particularly from socially and economically weaker sections for various competitive examinations for employment or admission to higher studies.

### PACKET 1 (Technical Documents)

The Packet 1 shall contain the documents as specified in the Qualification Requirements and as specified at Point 4.

### PACKET 2 (Financial Bid)

The Packet 2 shall contain ONLY financial quote as per the Annexure B. The Financial Bid shall be opened of only such bidders who will meet the Qualification requirements.

#### 1. QUALIFICATION REQUIREMENTS

- 1. Coaching institute should be registered under relevant Registration Act / Proprietorship Act. / GST Act.
- 2. The Bidders, whose offers are responsive against the minimum eligibility criteria, will be considered for further processing. The Financial Bid shall be opened of only such bidders who meet the Qualification requirements.
- 3. The selected bidder shall have to depute the resource persons / faculty to the University for coaching of candidates.
- 4. The University shall provide space / accommodation for the coaching.
- 5. Coaching institute should have minimum 05 years of experience of having provided coaching for Competitive Examinations.
- 6. Coaching Institute should submit Income Tax returns for the last 03 financial years (2019-20, 2020-21 and 2021-22).

- 7. Coaching Institute should have average turnover of at least Rs. 50 lakhs in last 03 financial years (2019-20, 2020-21 and 2021-22). A certificate to this effect shall be provided as per Annexure-A.
- 8. Coaching institute should have quality study material / well-equipped quality digital learning on dedicated online platform either developed or maintained in- house or in collaboration with reputed institutions.
- 9. Coaching institute must provide self-declaration certificate attested by the notary stating that the Institute / firm is not blacklisted by Government of India / UT of J&K.
- 10. Coaching / Training at franchise shall not be allowed.

## 2. FINANCIAL REQUIREMENTS

The Coaching / Training Institute should quote fee per candidate, inclusive of Coaching charges, Supply of printed Textbooks and study materials / digital materials that shall be provided to candidates with all other applicable taxes as per Annexure B.

## 3. GENERAL TERMS AND CONDITIONS

- 1. Conditional EOIs are liable for rejection.
- 2. The EOI acceptance authority / technical evaluation committee reserves the rights to reject any or all tenders without assigning any reason.
- 3. Any negotiation shall be done by the EOI accepting Authority/committee.
- 4. The selected coaching institute should not sublet the contract. If the teaching institute is found to have done so, the contract will be terminated at the risk and cost of the teaching institute concerned.
- 5. The successful bidder must provide all the resource manpower from the date of starting of coaching, failing in which penalty shall be imposed on the bidder as decided by the committee.
- 6. All disputes arising out of this contract shall be within the jurisdiction of the courts in Srinagar only.
- 7. The conditions stipulated in the agreement shall be strictly adhered to and violation of any of the conditions shall entail termination of the contract without prejudice to the rights of the University with such penalties as specified in the Agreement.
- 8. Rejection Criteria:

Besides other conditions and terms of the tender document, bids may be rejected under the following circumstances:

- A. If the information provided by the Bidder is found to be incorrect / misleading at any stage / time during or afterwards the Tendering Process.
- B. Any effort on the part of a Bidder to influence the bid evaluation, bid comparison or contract award decisions.
- C. Bids without signature of person (s) duly authorized on required pages of the bid.
- D. Bids without power of authorization and any other document consisting of adequate proof of the ability of the signatory to bind the Bidder. E. Failure to furnish proofs for information provided.
- F. The Bidder not conforming to unconditional acceptance of full responsibility of providing services in accordance with the Agreements of this tender.
