# SELECTION OF CONSULTANT FOR PREPARATION OF DETAILED PROJECT REPORT (DPR) FOR SETING UP 10 MWp GRID - CONNECTED GROUND MOUNTED SOLAR POWER PLANT AT CAMPUS – II, IUST AWANTIPORA

For and on behalf of IUST, the EOI has been floated for Engagement of Consultant to prepare a Detailed Project Report (DPR) related to development of 10 MWp Grid- Connected Ground Mounted Solar Project at IUST Awantipora. The intended Bidders should quote the rate including all kind of taxes (Central and State taxes etc.) in Indian Currency.

- Objective of Engagement: The consultant shall prepare a Detailed Project Report (DPR) for development of 10 MWp Ground Mounted Solar Project including indicative level Transmission Network & Sub Station for evacuation of Solar power.
- 1.1 **Location of the Project:** IUST Campus II Awantipora Kashmir.

Longitude: 75.025939° Latitude: 33.930119°

Elevation: 1790m above sea level

- 1.2 The DPR is to be prepared as per the specific site and location of the project. The intended bidders are advised to conduct a site survey before preparation of detailed project report. The Ministry of New and RenewableEnergy (MNRE), Government of India and State Policy (if any) of Jammu Kashmir Power Development Corporation Limited (JKPDC) / Jammu & Kashmir Energy Development Agency (JAKEDA) should be followed during the preparation of DPR.
- 1.3 It shall be imperative on each intended bidder to fully acquaint himself of all local conditions and factors, which may have any effect on the execution of the contract covered under these documents and specifications. It must be understood and agreed that such factors have properly been investigated and considered while submitting the proposals. It may be noted that IUST Campus is manned by its own security personnel.

#### 2. Eligibility Criteria:

- a. The bidder can either be a firm/organization registered in India under the legal applicable laws or a consultant approved by the government agency to undertake such contracts shall be eligible for the bid.
- b. The following are the minimum eligibility criteria:
  - The Bidders must be a reputed consulting Company / Firm with high degree of technical and
    financial capability with understanding and experience of multiple aspects of complete Solar
    System & Distribution System planning including engineering, Survey/ GIS mapping works,
    Socio- economic analysis & conducting technical studies as required for the preparation of
    DPR etc., and shall substantiate their claims by submitting the relevant documents.
    - The Bidder's Consultant/Consultant should have prepared/assisted in at least one DPR

- /study of at least comparable magnitude related to the project in the last five (05) years for the Government Department/Private Organizations/Ministries etc.
- The average annual turnover of the bidder should be on the positive side over last three financial years.
- The Bidders should have a registered office in the country and staffed with the requisite manpower forpreparation of DPR.
- c. Proposals of all the bidders shall be evaluated based on appropriate marking system. Thecategories for marking and their respective weightage are as under:

3. **Selection of the Consultant/Bidder for Engagement:** Only top six bidders as per their score of the technical bid shall qualify and be selected for opening of financial bid.

The formula for selection of the bidder shall be based upon Total Score calculated from Combined Technical Bid and Financial Score (CTFS):

Total Score = (0.7\*Marks scored in Technical Bid) + (0.3\* Financial Score)

Calculation of Financial Score: (LFB/F \* 100)

LFB = Lowest Financial Bid Amount, F = Quoted Amount

- 4. **Indicative Scope of Services:** The scope of work for preparation of DPR for development of 10 MWp Ground Mounted Grid-connected Solar Project including Transmission Network & Sub Station for evacuation of Solar power at IUST Awantipora shall be as follows:
  - a. Site visit and data collection: To conduct site visit and necessary data collection required for preparation of DPR
  - b. Feasibility analysis report
  - c. Detailing of existing scenario
  - d. Suitable technology to be adopted
  - e. Preparation of Concept Plans/ Simulation Data with drawing etc.
  - f. Budget estimation
  - g. Projected revenue generation under different business models like CAPEX/BOOT/BOO etc as applicable to solar power plants.
  - h. Any other Items/works, which are not mentioned above and required for the preparation of DPR.
  - i. Bidding and Evaluation of the bids received and furnishing award recommendation report to university for the award of the Contract for establishing solar park.
  - i. Preparation and floating of tender document for selection of the EPC
  - 5. **Deliverables and Schedule of Delivery:** The deliverables and schedule of delivery for DPR for development of 10 MWp Ground Mounted Solar Project including Transmission Network & Sub Station for evacuation of Solar power at IUST Awantipora are as under:

- a. DPR preparation should include a section on feasibility covering distribution network & Sub Station for evacuation of Solar power at IUST Awantipora. DPR submission shall be within 06 weeks from the date of signing the contract.
- b. Bidder shall be called for a presentation before the authority of IUST Awantipora

#### 6. Selection of Agency

The broad procedure for engagement of Consultant/Bidders constitutes as under:

- a. **Submission of EOI:** Bidders shall submit its EOI in two forms; the technical proposal, and the financial proposal.
- b. The bidder shall seal the technical proposal and the financial proposal in two separate envelopes, which shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL". These two envelopes shall then be sealed in a single outer envelope (MAIN ENVELOPE) and clearly mark as "EXPRESSION OF INTEREST (EOI) FORSELECTION OF CONSULTANT/BIDDER FOR FEASIBILITY TEST and PREPARATION OF DETAILE PROJECT REPORT (DPR) FOR SEETING UP 10 MWp GROUND MOUNTED SOLAR POWER PLANT AT IUST AWANTIPORA" as per the mentioned schedule through Speed Post Registered Post /Courier or By Hand at the address mentioned below:

- c. Scrutiny & Selection: IUST shall scrutinize all the submissions received on the basis of eligibility criteria and selection to be made accordingly.
- d. Cost of Bid Documents: The cost of bid documents is Rs. **1000/- (Rupees One thousand only)** inclusive of GST in the form of demand draft /Bankers Cheque in favor of "Finance Officer, IUST" from any nationalized/ scheduled bank payable at IUST.
- e. Another sealed envelope containing the HARD COPY of Cost of bid document of Rs. **1000/- (Rupees One thousand only)** inclusive of GST in the form of demand draft

/Bankers Cheque in favor of "Finance Officer, IUST" from any nationalized/scheduled bank payable at IUST, shall be put in the "Main Envelop, which contains Technical and Financial Bid, failing which the bidder shall not be considered for evaluation.

f. If the envelope is not sealed and marked as mentioned above, IUST shall not be responsible for any misplacement or premature opening. (Telex, cable or facsimile EOI shall be rejected).

#### 7. Pre-Bid Meeting:

There shall be a pre-Bid Meeting if required. Queries related to the bid process may be sent to the E mail ID mentioned above on or before 17-11-2023.

#### 8. **Termination of Engagement**:

If in the view of IUST, performance of a Consultant/Bidder is not satisfactory IUST may at its sole discretion, terminate the engagement of the Consultant/Bidder. In doing so, it shall intimate the Consultant/Bidder through a written termination letter. The decision of IUST in this matter shall be final and binding.

#### 9. Award of Work:

Letter of Award (LoA) shall be given to the selected Consultant/Bidder and an agreement shall be executed within 7 (seven) days of issuance of Letter of Award (LoA). The selected agency shall have to submit performance security @ 3% of the bid amount in form of Performance Bank Guarantee (PBG) for the contract period from any nationalized/ scheduled bank in India during signing of agreement IUST.

#### 10. Payment Conditions:

The terms of payment shall be as per the following conditions:

- i. 90% of payment shall be made on submission of DPR up to the satisfaction of authority (including three printed copies).
- ii. 10% of payment shall be made on completion of vetting procedure and final approval of the Competent Authority.

#### 12. Final Decision of the Authority:

IUST reserves the right to accept or reject any application and to annul the process and reject all/any application at any time without assigning any reason thereof.

#### 13. **Submission Requirements**:

To be eligible for engagement, the Bidders shall provide the following documentary evidence:

- a) Forwarding Letter.
- b) Copies of original documents defining the legal status, structure of organization, place ofbusiness of the company or corporation or firm or partnership in Schedule 'A';
- c) Reports on the financial standing of the Bidders in Schedule 'B';
- d) Details of the experience and past performance of the Bidders on works of a similar nature

and details of current works in hand and other commitments in Schedule 'C';

- e) Photocopies of Income Tax return of the firm for the last 3 years;
- f) Audited balance sheet of last three years.
- g) ITR of last three years.
- h) Certification by the agency that they have not been blacklisted/banned in any part of thecountry

#### 14. Language of Application:

The language of the application as well as the supporting documents shall be in English.

#### 15. Number of EOIs:

A Bidders shall submit only one Application.

#### 16. EOI Submission Date:

EOI submitted in all respect must reach at the specified address by the date as mentioned above.

#### 17. Late Submission:

EOI received after the deadline for submission prescribed by IUST shall be rejected. IUST shall not be responsible for postal delay

#### 18. Modification and Withdrawal of EOI:

No modifications to the EOI or withdrawal shall be allowed once the EOI is received by IUST.

#### 19. Date for Opening of EoI:
