The Bidders are expected to go through all instructions, terms & condition as specified in the bidding document. Failure to furnish complete required information or submission of a bid with incomplete information may result in rejection of the bid.

GENERAL TERMS & CONDITIONS

1. The tender duly completed and signed shall be submitted in a sealed cover. The sealed cover upper-scribed “**Tender for supply and refilling of commercial gas cylinders**” shall be addressed to the **Assistant Registrar (Procurement & Stores)** Islamic University of Science and Technology, Awantipora Pulwama and shall be submitted on or before **03-11-2025 12.30 pm**.
2. The Tender should be accompanied with Earnest Money Deposit (EMD) of Rs. 10,000/- (Ten Thousand only) in the shape of FDR/CDR of any nationalized Bank drawn in favour of “Islamic University of Science and Technology”, payable at Awantipora, Pulwama (J&K).
3. **The bidder shall have to deposit the EMD in the form of CDR/FDR only. Demand Draft will not be accepted.**
4. The intending bidders shall have to paste transparent tape on the rates quoted by them in Indian Rupees (INR) only both in figures and in words **FOR IUST Stores Awantipora**, inclusive of supply (loading/unloading) and all taxes . In case of a discrepancy, the amount quoted in words will be taken as final.
5. The Tender submitted shall remain valid upto 31st of March, 2026 from the date of opening of the tender.
6. The discount on the current Company Price list offered by the bidder will remain valid for supply and refilling of commercial gas cylinders till 31st March, 2026.
7. The supply, transportation etc. of the gas shall be sole responsibility and at the risk of the firm till the acceptance by the University.
8. The supply and refilling of commercial gas cylinders supplied will be inspected by a Committee specially constituted for the purpose and in case the Committee is of the opinion that the supplies are not of the required weight, the supplies shall be rejected and responsibility of lifting back the supplies will devolve on the supplier.
9. The University reserves the right to reject or accept any Proposal without assigning any reason or cancel or withdraw the tender. The University reserves the right to relax any condition enumerated or arising out of this tender, without assigning any reason/s thereof. If the supply of the required items are not affected before the specified period, the University shall have the authority to cancel the order or to take any action deemed fit in the circumstances.
10. In case of any dispute the jurisdiction will be courts at Srinagar only.
11. The University may, for any reason, whether suo-moto or in response to a clarification requested by a prospective bidder, modify the bidding document by an amendment, any time prior to the last date for submission of bids.
12. Tenders received after due date, improperly sealed, or with incomplete marking or with overwriting/corrections are liable to be rejected.
13. During evaluation of bids, the University may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing and no change in prices or substance of the bid shall be sought, offered or permitted.
14. Failure of the successful bidder to comply with the requirements of the University shall constitute sufficient ground for the annulment of the award and forfeiture of the EMD, in which event the University may make the award to the next bidder or call for new bids.
15. **The successful bidder shall have to provide 700 commercial gas cylinders on 12-11-2025 to the University.**

- a. EMD (in the form of CDR/FDR). Demand Draft or cheque will not be accepted
- b. Authorized dealership/Distribution certificate
- c. GST Registration.
- d. PAN Card

I/We hereby declare that the information furnished above is true and correct.
