BoRS Chairman, Prof. Shakil Ahmad Romshoo in his welcome address highlighted the significance of holding BoRS meetings across the various Schools of the University in a timely manner. He stressed that the Departments should hold the pre-BoRS meetings at the school level in order to examine the agenda items before their placement in BoRS. The Heads of the Departments were stressed that as per the University Ordinance, Schools have to hold the BoRS meeting twice a year so that the recommendations/decisions of the Board are confirmed in the BoRS meetings immediately. This will ensure that Research Scholars don't lose their precious time in waiting for the outcome of the BoRS resolutions. He also remarked the significance of the Departmental Research Committee (DRC) by acting as the first check-point for conducting the quality research.

Prof. Shakil Ahmad Romshoo also remarked that there should be a uniform synopsis format at the school level for which the Dean of the concerned Schools in consultation with HoDs will recommend the synopsis format that will be approved by the Competent Authority. Thereafter, the format shall be made available on the University website for easy access of Scholars/Supervisors.
